### CECILY KANTER, PSY.D.

is a Licensed Clinical Psychologist with extensive experience working with children, adolescents, and adults. She earned both a Master's and Doctoral degree from the Illinois School of Professional Psychology in 2007 and holds a Bachelors of Science in Psychology and Sociology from Tulane University. Dr. Kanter has completed years of specialized training in therapy and diagnosis of children and adolescents in addition to her extensive work with adults and families. She completed her psychological assessment training at the Village of Hoffman Estates Department of Health and Human Services, later completed her Doctoral internship at New Connections Academy in 2007. She later became the Clinical Director at New Connections Academy, working directly with clients and families, as well as supervising trainees and clinical staff. Currently, she is working in private practice.

Dr. Kanter has dedicated her career working with individuals who suffer from the following: autism spectrum disorders, developmental delays, learning disabilities, anxiety related disorders, mood disorders, grief/loss, life transitions, and postpartum depression. Due to her extensive work in therapeutic day schools, Dr. Kanter collaboratively works with parents of children with Individual Education Plans (IEP) and other alternative needs in school, by empowering them to advocate and obtain the best and most appropriate services afforded to their child.
