## **Various Ways to Donate**

**Corporate Partners:** Area corporations and businesses may partner with Allendale to sponsor an Event/Benefit or coordinate and participate in "Day of Caring" volunteer events on campus and/or at our various locations. **Annual Fund:** If you are interested in supporting the general operations of Allendale, you can mail your gift to the Development Office at Allendale (P.O. Box 1088, Grand Avenue & Offield Drive, Lake Villa, IL 60046) or you can use your credit card to make a gift online.

If you would like to participate in the Annual Fund but are unable to make your contribution right away, we would be glad to send you a pledge reminder. Just let us know the amount you wish to contribute and the date you would like to be reminded.

**Gifts of Endowment Funds:** The gift of an endowment to Allendale is an excellent way to ensure future excellence in perpetuity. It also provides the donor with the satisfaction of knowing that his or her generous legacy will continue as long as Allendale exists. While endowments may be established to support virtually any activity or program at Allendale, we have a critical need for general Board-designated endowment funds. This allows the Board of Trustees the flexibility to spend endowment earnings as needs arise, thus making the best choice for the use of funds in any given year.

**Scholarship Funds:** Allendale's generous and devoted donors and friends continue to support scholarship opportunities for our youth. The donations have been placed in restricted funds to provide scholarships for candidates who demonstrate economic need and who show evidence of the ability to succeed in our programs.

**Gifts of Cash:** Cash gifts can be made as a one-time contribution, reoccurring, or over several years as payments toward a pledge. Checks should be sent with any designated purpose for the gift clearly indicated. Gifts delivered or mailed by December 31 qualify for tax deductibility for the calendar year. Please make checks payable to Allendale Association.

**Gifts of Stock:** Stock gifts can be donated directly to Allendale. If you have held the investment for at least one year and it has appreciated, donating the stock directly to Allendale helps you avoid the capital gains tax which would otherwise be due on a sale of stock. The income tax deduction would be for the full current value of the investment at the time of the gift. Please contact us at 847-245-6204 for the proper paperwork to initiate this type of gift.

**Gifts-In-Kind:** We do accept some in-kind donations! Please contact us at 847-245-6204 to determine if your gift-in-kind donation can be used directly by one of our program areas! This type of gift provides a charitable deduction equal to the fair market value of the property donated (as determined by the donor).

**Memorial/Tribute Gifts:** Allendale can accept and acknowledge gifts given in honor of or in memory of an individual. Whether your tribute gift is an expression of sympathy or marks a special achievement and honors a person, it provides a unique way to provide a gift that may be appreciated more than a material gift.

The amount of your gift is kept confidential, and the friend or family member is informed of your thoughtfulness through an acknowledgement card from Allendale.

**Matching Gifts:** You may be able to double or triple your gift through your company's matching gift program. If your employer makes such contributions, the personnel office will have complete details on

how to direct a matching gift to Allendale. Matching funds, once received, will count toward your yearly contribution.
