"To be honest, none of us made it to graduation just by ourselves. When I think about any accomplishments I have made during my time here, I think of all the people who have been supporting me and helping me grow:

My Mom – is like my best friend. She has been there since day one, always with me, even during the tough times.

Ms. Cathy – showed me the importance of learning and the reason why you should try your best. She definitely helped make sure I recognized wrong from right.

Dan – helped me when I was struggling. I could depend on going to him for advice, no matter how hard it got. I also made him help me with a lot of math – which I don't think he enjoyed too much.

C.C. – helped me unlock a person inside me that I never knew I had.

Tolise – means a lot to me -- she kept my head up during some pretty dark times. I also enjoy bickering with her – but that's all in good fun.

Fill-A-Heart Volunteers -- taught me to keep a smile on my face even when I was sad, and they taught me how to keep my sadness from stopping me from doing good things.

I will never forget any of these experiences or the changes I have made inside of myself: controlling anger; using coping skills; managing negative comments; and distancing myself from drama. All of these new skills have made life much more emotionally comfortable.

The me who first arrived here at Allendale thought everything would just happen without any effort, well, the new me now has goals and plans for the future. When I am an adult, I want to work at a job that will allow me to help kids like I have been helped." --K. H.

Now I find that I'm not as timid or scared as I used to be and I'm beginning to overcome my anxiety and low self-esteem.

I've also realized that throughout my life, my Mom and my Grandmother have been my biggest supporters. They've been with me since day one and I know that they will continue to be there for me rooting me on in life." --O. R.






